For and in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations, the receipt of which is hereby acknowledged, we, DORIS POUNDERS KING and CLARENCE OPAL POUNDERS, Grantors herein, do hereby convey and warrant unto BOBBIE POUNDERS KING and husband, M.L. KING, as tenants by the entirety, our undivided two-thirds (2/3) interest in the below described real estate, together with all the appurtenances and hereditaments thereunto belonging or in any wise appertaining, in DeSoto County, Mississippi, more particularly described as follows:

Being in the northwest quarter of Section 23, Township 1, Range 6 West. Commence at the northwest corner of said section; thence southward along the west line of said section approximately 1620 feet to the centerline of Woolsey Road, the point of beginning. Thence continuing southward along said west line approximately 1045 feet to the half section line of said section; thence eastward along said half section line 552.42 feet to the east line of the E.P. Pounders tract; thence northward along said east line approximately 1042 feet to the centerline of said Woolsey Road; thence westward along said centerline of Woolsey Road approximately 552 feet to the point of beginning. Containing 13.2 acres, more or less. Being part of that tract conveyed to E.P. Pounders et ux by Correction Deed dated December 19, 1956, and recorded in Deed Book 44 at page 389.

By way of explanation, Earnest P. (E.P.) Pounders died in February, 1980, and his wife, Mary Lee Stone Pounders, died in 1967, leaving as their only children, Doris Pounders King, Clarence Opal Pounders, and Bobbie Pounders King.

The warranty in this deed is subject to an easement for Woolsey Road, to easements for public utilities, and to subdivision and zoning regulations for DeSoto County, Mississippi.

Taxes are to be prorated, and possession is given with delivery of this deed.






