FOR AND IN CONSIDERATION of the love and affection that I have for the Grantees, I, Hubert C. Thompson and wife, Dorothy M. Thompson, to hereby give, convey and warrant unto Roy Douglas and wife, Deborah Thompson Douglas, as tenants by the entirety with full rights of survivorship and not as tenants in common, the following described land lying and being situated in the County of Desoto, State of Mississippi, more particularly described as follows, to-wit:

Part of Section 20, Township 2 South, Range 8 West, Chickasaw Cession, Desoto County, Mississippi, being more particularly described by metes and bounds as follows: BEGINNING at a point in the southeast line of Horn Lake Road (80.00 feet wide), a distance of 300.00 feet southwestwardly as measured along the southeast line of Horn Lake Road from its intersection with the North line of the Southeast quarter of the southeast quarter of Section 20, said point of beginning being the southwest corner of the Jack Wiley lot as recorded in Book 138, page 717, in the office of the Chancery Clerk of Desoto County, Mississippi; thence South 23 degrees 23 minutes West along the southeast line of Horn Lake Road, a distance of 180.00 feet to a point; thence North 86 degrees 13 minutes East, a distance of 340.00 feet to a point; thence North 23 degrees 23 minutes East parallel with the southeast line of Horn Lake Road, a distance of 180.00 feet to a point in the south line of the Jack Wiley Lot; thence South 86 degrees 13 minutes West along the South line of said Wiley lot, a distance of 340.00 feet to the point of beginning, containing 1.25 acres, more or less.

The warranty in this Deed is subject to subdivision and zoning rules and regulations of Desoto County Planning Commission, and rights of ways and easements for public roads and public utilities.


