A. Dunn, do hereby sell, convey, bargain and quitclaim unto the LEBANON CEMETERY ASSOCIATION, INC., A Non-Profit Mississippi Corporation, the property lying and being situated in DeSoto county, Mississippi, more particularly described as follows, to-wit:

BEGINNING at the northeast corner of Section 28, Township 2 South, Range 6 West, DeSoto County, Mississippi; thence West 1402.50 feet along Bethel Road to the point of beginning; thence South 183.86 feet to an iron pin, said point being 20.2 feet East of an old fence corner; thence South 78 degrees 43 minutes West along an old fence 33.45 feet to an old iron fence post; thence North 68 degrees 06 minutes West along an old fence 129.97 feet to an old iron fence corner; thence North 36 degrees 55 minutes east along an old fence 251.11 feet to an iron pipe; thence East 296.76 feet to the point of beginning, containing 79,484.35 square feet or 1.83 acres.

By way of further explanation, the purpose of this deed is to convey any interest that the Grantor herein may own by virtue of being a heir of one T. A. Dunn.


