

In consideration of One Dollar (\$1.00) and other good and valuable considerations, we, Jean Mormon, a/k/a Doris J. Garmon, George Abram, J. Lee Ethel-Abram Richardson, Michael Lynn Abram, Chester Clyde Abram, Edna Fay Abram, Timothy Carl Abram, and Hermon Lenord Abram, a/k/a Herman Lenord Abram,

convey and warrant to DeSoto County, Mississippi the land in DeSoto County, Mississippi described as part of the Southeast Quarter of Section 6, Township 2, Range 7 and being a strip of land 40' North of the center of Church Road, more particularly described as follows:

Beginning at the Southwest corner of the Southwest Quarter of the Southeast Quarter of Section 6, Township 2, Range 7; thence Eastwardly along the proposed centerline of Church Road and the Section line to the Southwest corner of the Southeast Quarter of the Southeast Quarter of said Section 6; thence North 40 feet; thence west and parallel to the proposed enterline of Church Road to a point 40 feet North of the Southwest corner of the Southwest Quarter of the Southeast Quarter of said Section 6; thence South 40 feet to the point of beginning.

This deed conveys 40 feet North of the centerline of proposed Church Road whether correctly described or not.

I fully understand that I am entitled to be duly compensated for the property herein conveyed, but I have elected to donate the same to the County for the nominal consideration recited above.

A 10-foot easement is granted beyond this right of way for use in sloping the fill or cut of said road where necessary.

DeSoto County will not be required to rebuild any fences.
