For and in consideration of the sum of One Dollar (\$1.00), cash in hand paid, and other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged, We, do hereby sell, convey and quitclaim unto Johnny H. Jackson all our right, title and interest in and to the land lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

Lot 1682, Section D, in DeSoto Village (Belle Meade) Subdivision on Section 33, Township 1 South, Range 8 West, as shown by the plat recorded in Plat Book 10, Page 9 in the office of the Chancery Clerk of said County and being more particularly described as follows:

Beginning at a point on the North line of Bryn Mawr Drive, a distance of 112.49 feet Westerly, as measured along the North line of Bryn Mawr Drive from the tangent intersection with the West line of Belle Meade Road, said point being the Southwest Corner of Lot 181; thence Westerly, along the North line of Bryn Mawr Drive, on a curve to the left, having a radius of 50.00 feet and an arc distance of 67.81 feet; thence N 32° 50' 45" W. along the line between Lots 1682 and 1683, a distance of 169.85 feet; thence N 89° 51' 30" E, a distance of 153.79 feet; thence S 00° 08' 30" E, parallel to the West line of Belle Meade Road and along the line between Lots 1681 and 1682, a distance of 150.00 feet to the point of beginning.

By way of explanation, this is the same property as conveyed to Johnny H. Jackson, et ux by Warranty Deed dated October 4, 1973 and recorded in Warranty Deed Book 108, Page 158, in the office of the Chancery Clerk of DeSoto County, Mississippi.
