FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00), cash in hand paid, receipt of all of which is hereby acknowledged, and other good and valuable considerations, we, Robert Moore and wife, Ruth Moore, do hereby bargain, sell, convey and quitclaim unto Whitley R. Stephens, and wife Janet R. Stephens, as tenants by the entirety with the right of survivorship and not as tenants in common, all our right, title and interest in and to the property lying and being situated in DeSoto County, Mississippi, described as follows, to wit:

Tract I. 7 1/2 acres more or less, in the southwest quarter of Section 16, Township 2, Range 6, described as BEGINNING at a point 554.5 feet east of the southwest corner of Section 16 (which point is the southeast corner of the Keith Redding 7 1/2 acre tract); thence with the Keith Redding east line run north 1110.5 feet to a point in the south line of the Downer 2 acre tract; thence with Downer's north line, run east 290.5 feet to Downer's southeast corner; thence with the Ross west line, run South 1006 feet to a point; run west 104.5 feet to a point; run thence south 104.5 feet to a point in the South line of Section 16; thence with said line, run west 166 feet to a point of beginning and being the same property described of record in Book 129, Page 222, Warranty Deed Records, Office of the Chancery Clerk, DeSoto County, Mississippi.

Also a right of way for ingress and egress 30 feet in width from Dunn Road along the Downer West line and South line to the above described tract.

Tract II. Lot No. 58 of Smokey Hollow Farms containing 3.159 acres in Section 33, Township 3 South, Range 5 West, a plat of said Smokey Hollow Farms is recorded in the land records of said County in Plat Book 9, Pages 13, 14 and 15.


