GRANT OF EASEMENT

(GENERAL)

For good and valuable consideration, receipt of which is hereby acknowledged,
Mrs. Willie Mack Founders By Percy Founders

do(es) hereby grant to Home Telephone Company, a Mississippi corporation, its successors and assigns, an easement to construct, operate, maintain, replace and remove such aerial and underground telephone, telegraph and communication structures as Grantee may from time to time require, consisting of poles, anchors, wires, cables, conduits, manholes, markers, and necessary fixtures and appurtenances, over, under, and upon that certain real property in the County of DeSoto, State of Mississippi, described as follows:

RIGHT OF WAY TO ATTACH TO EXISTING POLE LINE IN NW 1/4 OF SECTION 32 TWP. 15 RING SW, APP. 2250'

VERBAL PERMISSION TO PLACE CABLE ON EXISTING POLE LINE AS PER CONVERSATION WITH PERCY FOUNDERS AT HIS HOME ON ABOVE DATE AT APP. 7:30 P.M. MR. FOUNDERS AGREES TO SAID CONSTRUCTION BUT REFUSES TO SIGN EASEMENT 895-2387

The Grantee shall have the right to clear the right of way hereby granted and keep the same free of brush, tree or root growth, and any other obstruction to such extent as may be necessary to prevent contact or interference with said lines and the operation thereof, and to protect persons from injury or death, and said lines and other property from fire, destruction or damage; and to enter upon and travel, including transport of materials, over and across the above-described real property for all uses in the exercise of the right of way and easement rights herein granted; provided that such right shall be reasonably exercised and that the Grantee shall be liable for any damage done by it to the said land and real property.
