

ROAD RIGHT OF WAY DEED

In consideration of One Dollar (\$1.00) and other good and valuable considerations, We, Jones Carter Wash, Donald Lee Wash, Ronald Lee Wash and Samuel Everett Long conveys and warrants to DeSoto County, Mississippi the land in DeSoto County, Mississippi described as part of the Northeast Quarter of Section 5, Township 3 South, Range 5 West and being a strip of land South of the center line of proposed Byhalia Road, more particularly described as follows:

Beginning at the northwest corner of the samuel and Neva Long tract in Section 5, Township 3 South, Range 5 West; thence south along west line said tract to a point 40 feet south of center of proposed Byhalia Road; thence east and parallel to center said road 875 feet, more or less, to a point in east line said tract, said point being 40 feet south of center said road; thence north along said east line to north line Section 5; thence west along said north line 875 feet, more or less, to the point of beginning.

This deed conveys 40 feet south of the center line of proposed Byhalia Road whether correctly described or not.

We fully understand that we are entitled to be duly compensated for the property herein conveyed, but we have elected to donate the same to the County for the nominal consideration recited above.

A 10 foot easement is granted beyond this right of way for the use in sloping the field or cut or road and/or drainage work, where necessary.

DeSoto County (will) (will not) be required to (build) (rebuild) any fences.
