
FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00), cash in hand paid and other good and valuable considerations, the receipt of all of which is hereby acknowledged, we, ROBERT M. WILLIAMS, JR., JON A. REEVES, and VERNON HOBBS, do hereby bargain, sell, and convey unto HAROLD E. CRYE and JAMES F. HUNTZICKER and wife, BARBARA A. HUNTZICKER, all of our right, title, and interest in and to that certain non-exclusive easement for road purposes in and to the lands lying and being situated in the City of Southaven, DeSoto County, Mississippi, described as follows, to-wit:

The east 5.8 feet of Lot 4, Williamsburg Village in the City of Southaven, Mississippi, in Section 23, Township 1 South, Range 8 West, DeSoto County, Mississippi, as shown by plat appearing of record in Plat Book 20, Page 6, in the office of the Chancery Clerk of DeSoto County, Mississippi and being more particularly described as follows: BEGINNING at the intersection of the south right of way of State Line Road and the east right of way of Moss Point Drive; thence east along the said south right of way of State Line Road 225.0 feet to a point, said point being the north east corner of Lot 4; thence go west along the south right of way of State Line Road 5.8 feet to a point; thence go south 160.0 feet to a point in the south line of Lot 4; thence east along said south line a distance of 5.8 feet to the southeast corner of Lot 4; thence north along the east line of Lot 4 a distance of 160.0 feet to the point of beginning, being that certain non-exclusive easement for road purposes conveyed to Grantors by instrument appearing of record in Book 160, on Page 229 of the Right-of-Way Deeds of DeSoto County, Mississippi.
