GLASS, Grantor herein, hereby quitclaims to LEROY J. GLASS, Grantee herein, the following land lying and situated in DeSoto County, Mississippi, being more particularly described as follows, to-wit:

Lot 573, Section B, South 1/2, and Section East of Cow Pen Creek, in DeSoto Village Subdivision on Section 33, Township 1 South, Range 8 West, as shown by plat recorded in Plat Book 8, Pages 16 - 21, in the office of the Chancery Clerk of said County and being more particularly described as follows: BEGINNING at a point in the west line of Forest Glen Drive 175.0 feet southwardly from the point of intersection of said west line and the south line of Fair Meadow Drive; thence southwardly 65.0 feet with the west line of Forest Glen Drive to a point, the north east corner of lot 574; thence westwardly 130.0 feet with the north line of lot 574 to an iron pipe; thence northwardly 65.0 feet parallel with the west line of Forest Glen Drive to an iron pipe in the southwest corner of lot 572; thence eastwardly 130.0 feet with the south line of lot 572 to the point of beginning, as per survey by Acme Engineering Service dated Augsut 16, 1974, located in DeSoto County, Mississippi.


