

PARTITION DEED

For the purpose of dividing the South 56 acres of the North Half of the Southeast Quarter of Section 7, Township 3, Range 6 owned by JOSEPH COLE, who died in 1953, and his wife, ADDIE COLE, who died in 1980, and in consideration of the conveyance to us of other lands, their undersigned children and grandchildren convey and warrant to JAMES COLE the land in DeSoto County, Mississippi described as follows, to-wit:

Beginning at a point 766 feet South and 1,320 feet West of the Northeast corner of the Southeast Quarter of Section 7, Township 3, Range 6 at the Northwest corner of the Charles Cole tract; thence West along the South line of the Robert Cole tract 1,320 feet to a point; thence South 205 feet to a point; thence East along the North line of the Joseph Cole, Jr. tract 1,320 feet to a point; thence North 165 feet to the Point of Beginning and containing 5.6 acres, more or less, subject to a 20 foot easement for a private drive along the South line.






