

ROAD RIGHT OF WAY DEED

In consideration of One Dollar (\$1.00) and other good and valuable consideration, we, Robert Malone and ~~Adelle~~ Watkins Malone, convey and warrant to DeSoto County, Mississippi the land in DeSoto County, Mississippi described as part of the southwest quarter of Section 19, Township 1 south Range 5 west, and being a strip of land north of the center of a proposed road, more particularly described as follows:

Beginning at the southwest corner of the Malone tract in SW quarter Section 19, Township 1 South, Range 5 West; thence north along west line said tract to a point 25 feet north of a proposed road; thence east and parallel to center said road 879.76 feet, more or less, to east line said tract; thence south along said east line to southwest corner said tract; thence west along south line said tract 876.76 feet, more or less, to the point of beginning.

This deed conveys 25 feet north of the centerline of proposed road, whether correctly described or not.

I fully understand that I am entitled to be duly compensated for the property herein conveyed, but I have elected to donate the same to the County for the nominal consideration recited above.

No 10 foot A 10 foot easement is granted beyond this right of way for the use in sloping the fill or cut of said road where necessary.

DeSoto County will not be required to rebuild any fences.


