Grantors, do hereby grant, bargain, sell, transfer, convey and warrant unto _____
City of Southaven, Ms. P. O. Box 425, Southaven, Ms. 393-5431, Grantee, its successors and
assigns, a perpetual easement with the right to erect, construct, install and lay
and thereafter use, operate, inspect, repair, maintain, replace and remove storm drains,
mains and lines and connections and necessary appurtenances thereto, on, over, and
across the following described property situated in DeSoto County, Mississippi,
to wit

A 5 foot strip of land off the south line of the Grantors property
beginning at the Southeast corner extending north 5 feet and running
west parallel to the south line of the Grantors property terminating
at the west property line of the Grantors property, located in Section
24, Township 1 South, Range 8 West.

Together with the right of ingress and egress over Grantor's adjacent lands for
the purpose for which the above mentioned rights are granted.

The consideration recited herein shall constitute payment in full for all damages
sustained by Grantors by reason for the installation of the structures referred to herein
and Grantee will maintain such easement in a state of good repair and efficiency so that
no unreasonable damage will result from its use to Grantors premises. This agreement
together with other provisions of this grant shall constitute a covenant running with
the land for the benefit of the Grantee, its successors and assigns. The grantors do
