

AFFIDAVIT OF HEIRSHIP OF  
VIRGINIA PEARL POWERS

AFFIANTS DIANA GALE MORELOCK, ANNA NELSON and IRENE LAMERE, on oath swear that the following statements are true:

Affiant DIANA GALE MORELOCK, is the surviving daughter of VIRGINIA PEARL POWERS. Affiants ANNA NELSON and IRENE LAMERE were well and personally acquainted with the family history of VIRGINIA PEARL POWERS, Deceased.

That VIRGINIA PEARL POWERS was also known as GINNY PEARL POWERS.

That VIRGINIA PEARL POWERS was born on July 16, 1921, in Georgia, and died intestate a resident of Grand Prairie, Dallas County, Texas, on July 21, 1988, at the age of 67 years. Affiants know of no completed, pending, or contemplated administration of the estate.

That VIRGINIA PEARL POWERS was married four times as follows:

- 1. The first marriage was to GEORGE BINGHAM BACHE, JR. in 1937.

That VIRGINIA PEARL POWERS and GEORGE BINGHAM BACHE, JR., were divorced in the year 1940, in the State of Georgia. To the union of VIRGINIA PEARL POWERS and BINGHAM BACHE, JR., there was born one child, a boy, GEORGE BINGHAM BACHE III, born on the 17th day of June, 1938 in Georgia, whose address is P. O. Box 80746, Atlanta GA. 30366.

- 2. The second marriage was to ALEXANDER REID WICKER on October 2, 1943, which marriage was annulled in approximately three months later in 1943, in Georgia. No child or children were born to this marriage.

- 3. The third marriage was to ROBERT C. KEITH on July 13, 1946.

That VIRGINIA PEARL POWERS and ROBERT C. KEITH were divorced on June 5, 1967, in the State of Texas. To the union of VIRGINIA PEARL POWERS and ROBERT C. KEITH there were born two children, as follows:

- 1. DIANA GALE KEITH MORELOCK, a girl, born July 3, 1947.
- 2. ROBERT CHARLES KEITH JR., born September 5, 1957, who died intestate on June 25, 1973, at the age of 16 years in Dallas County, Texas. That the estate of ROBERT CHARLES KEITH JR. was not of sufficient value to require filing of any federal estate tax return or state inheritance tax return, and no federal estate

taxes or state inheritance taxes were due on said estate. That there was no probate administration of the estate of CHARLES KEITH, JR.

4. That the fourth marriage was to RALPH FRED POWERS on January 16, 1968 in the State of Texas. That VIRGINIA PEARL POWERS and RALPH FRED POWERS were divorced December 7, 1984 in Mississippi. No child or children were born to this union.




