FOR AND IN CONSIDERATION the sum of Ten and no/100, cash in hand paid and other good and valuable considerations, the receipt of all of which is hereby acknowledged, we, SHERRIE MARIE GLOVER, DELOIS ROY, JOSEPH WILSON, ALICE GLOVER, DARLENE WILSON, CORNELL WILSON (one and the same person as CONNIE WILSON) do hereby sell, convey and warrant unto WILLIE HUE WILSON and wife, MATTIE MAE WILSON as tenants by the entirety with the right of survivorship and not as tenants in comman all our right title and interest in and to the land lying and being situated in DeSoto County, Mississippi described as follows to-wit:

5.0 acre tract in the Northeast quarter of Section 28, Township 1 South, Range 5 West, DeSoto County, Mississippi, being part of a 27 acre tract as recorded in Book 151, page 383 Chancery Clerk's Office, DeSoto County Mississippi, being more particularly described as BEGINNING at the Northwest corner of Section 28, Township 1 South, Range 5 West, DeSoto County, Mississippi, thence South 89 degrees 39 minutes 34.2 seconds East, along the North line of Section 28, a distance of 2.673.46 feet to a point; thence South 0 degrees 58 minutes 10 seconds West, along the 1/2 section line 1223.36 feet to a point, said point being the true point of beginning of the hereafter described 5.0 acre tract; thence South 89 degrees 37 minutes 23 seconds East, 466.70 feet to a point; thence South 0 degrees 58 minutes 10 seconds West, 466.70 feet to a point; thence North 89 degrees 37 minutes 23 seconds West, 466.70 feet to a point on the 1/2 Section line; thence North 0 degrees 58 minutes 10 seconds East, along the 1/2 Section line 466.70 feet to the point of beginning, containing 217,797.240 square feet or 5.0 acres.
