THOMAS, ROBERT DEEN AND IVAN BELANDER, JR., do hereby sell, convey and warrant unto GARNETT B. WEST, SR., the land lying and being situated in DeSoto County, Mississippi, more particularly described as follows, to-wit:

Lot 282, Section A, in DESOTO VILLAGE SUBDIVISION, in Section 34, Township 1 South, Range 8 West, as shown by the plat recorded in Plat Book 7, Pages 9-14, in the office of the Chancery Clerk of DeSoto County, Mississippi.

Further consideration for the hereinabove described property is the assumption by the Grantee of that certain Deed of Trust in favor of National Mortgage Company which is recorded in Deed of Trust Book 135, Page 78, and that certain Deed of Trust in favor of Commercial Credit Corporation which is recorded in Deed of Trust Book 393, Page 680, in the office of the Chancery Clerk of DeSoto County, Mississippi.

Grantors hereby set over and assign unto Grantee, without charge, all funds held in escrow in connection with the above mentioned loan.

The warranty in this deed is subject to subdivision and zoning regulations in effect in Horn Lake, DeSoto County, Mississippi, to rights-of-way and easements for public roads and public utilities, and to the restrictive covenants of record for said subdivision.

Taxes for the year 1989 are to be prorated.

Possession is to be given upon delivery of the deed.
