AFFIDAVIT OF HEIRSHIP

The undersigned, WILLIAM G. RAMSEY and JANE CAROL RAMSEY, having been duly sworn according to law, do hereby state as follows:

1. That the undersigned are the two (2) children of GLYN ELSWORTH RAMSEY, deceased, who died intestate a resident of Shelby County, Tennessee, on October 3, 1988.

2. That at the time of the death of GLYN ELSWORTH RAMSEY, he was unmarried. GLYN ELSWORTH RAMSEY was previously married to DOROTHY F. RAMSEY a/k/a DOROTHY GWENDOLYN RAMSEY, who died July 9, 1983, a resident of Shelby County, Tennessee. That at the time of her death, DOROTHY F. RAMSEY a/k/a DOROTHY GWENDOLYN RAMSEY and GLYN ELSWORTH RAMSEY were husband and wife. DOROTHY F. RAMSEY a/k/a DOROTHY GWENDOLYN RAMSEY had two (2) children, WILLIAM G. RAMSEY and JANE CAROL RAMSEY. GLYN ELSWORTH RAMSEY had no other wives nor did he have any children other than the affiants.

3. That at the time of the death of GLYN ELSWORTH RAMSEY, he was the owner of the real property, described as follows:


