

RELEASE OF EASEMENT

WHEREAS, by subdivision plat recorded in the land records of DeSoto County, Mississippi, a 5 foot wide utility easement was reserved along and adjacent to both sides of the northern boundary line of Lot 10 of Freeport Industrial Park subdivision, from the intersection with Rostin Road to the intersection of the east lot line of Lot 8 and 40.69 feet northerly along the west lot line of Lot 8 from its intersection with Lot 10, as per plat thereof recorded in Plat Book 11 at Pages 43 and Plat Book 14 at Page 3 in the office of the Chancery Clerk of said county and located in the northwest 1/4 of Section 22, Township 1 south, Range 8 west of said county; and

WHEREAS, said Lot 10 has been revised by new subdivision plat recorded in Plat Book 33 at Page 18 of the land records of said county to delete the necessity of the said easement and it is desired that utility companys release any interest in said portion of the easement:

THEREFORE, Mississippi Power & Light Company, an electric power utility operating in DeSoto County, Mississippi does hereby release and disclaim any interest to a platted 10 foot wide utility easement in Freeport Industrial Park, a subdivision according to a plat thereof recorded in Plat Book 11 at Page 43 and in Plat Book 14 at Page 3 in the office of the Chancery Clerk of DeSoto County, Mississippi, lying as follows:

That 10 foot wide easement 233.64 feet in length lying 5 foot either side of the common boundary of Lots 10 and 9 and 171.04 feet in length lying 5 feet either side of the common boundary of Lots 10 and 8. Also, that 10 foot wide easement 40.69 feet in length lying 5 feet either side of the common boundary of Lots 8 and 9 extending from the intersection of the lot line of Lot 10.
