

BARBOUR, Trustee, Grantor herein, hereby sells, conveys and warrants unto RICHARD L. STOCK and wife, PATSY M. STOCK, Grantees herein, as tenants by the entirety with full rights of survivorship and not as tenants in common, the following land lying and situated in DeSoto County, Mississippi, being more particularly described as follows, to-wit:

The northwest half of Lot 5, Block 1, Plat of Town of Olive Branch, DeSoto County, Mississippi; being more particularly described as follows: Located in Section 27, Township 1 South, Range 6 West, DeSoto County, MS. BEGINNING at the west corner of Lot 5; thence North 43 degrees 36 minutes East along the line dividing Lot 4 and Lot 5, a distance of 415.00 feet to the north corner of Lot 5; thence South 46 degrees 24 minutes East along the Northeast line of Lot 5, a distance of 105.00 feet to a point; thence South 43 degrees 36 minutes West parallel with the line dividing Lot 4 and Lot 5, a distance of 415.00 feet to a point in the southwest line of Lot 5; thence North 46 degrees 24 minutes West along the southwest line of Lot 5, a distance of 105.00 feet to the point of beginning, containing 1.0 acre.


