

ROAD RIGHT OF WAY DEED

In consideration of One Dollar (1.00) and other good and valuable consideration, we, Linda B. Edward, Onzie V. Bullard, Travis B. Bullard, Bertron Bullard, L. C. Oliver and Warlease B. Wiseman, convey and warrant to DeSoto County, Mississippi, the land in DeSoto County, Mississippi described as part of the Northwest Quarter of Section 8, Township 2 South, Range 7 West, and being a strip of land east of the center of Davis Road, more particularly described as follows:

Beginning at the intersection of the north line of the original Lincoln Bullard Tract and the centerline of Davis Road; thence east along said north line to a point 40 feet east of the centerline of said road; thence south and parallel with the centerline of said road approximately 20 feet to a point, thence west 40 feet to a point in the centerline of said road; thence north along the centerline of said road 20 feet, more or less, to the point of beginning, and being part of the property conveyed to the grantors herein by Warranty Deed of record in Book 233, page 787, Chancery Clerk's Office, DeSoto County, Mississippi.

This deed conveys 40 feet east of the centerline of Davis Road whether correctly described or not.

We fully understand that we are entitled to be duly compensated for the property herein conveyed, but we have elected to donate the same to the County for the nominal consideration recited above.

A 10 foot easement is granted beyond this right of way for the use in sloping the fill or cut of said road where necessary.

DeSoto County will not be required to build/rebuild any fences.
