QUITCLAIM DEED

For and in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid and other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged, MULLINS & ASSOCIATES, INC., does hereby sell, convey and quitclaim unto PAUL R. WEEKS AND WIFE EMOGENE R. WEEKS, as joint tenants with full right of survivorship, and not as tenants in common, the following described property situated in the County of DeSoto, State of Mississippi, together with all improvements and appurtenances thereon more particularly described as follows:

A 1.5 acre tract located in Section 36, Township 1 South, Range 9 West, DESOTO COUNTY, MISSISSIPPI, more particularly described as follows:

Beginning at an iron pin on the East right of way of Poplar Corner Road, said point being 2381.09 feet South and 53.0 feet East of the commonly accepted Northwest corner of said Section 36 and point of beginning this description; thence run North 06 degrees, 19 minutes, 48 seconds West along said right of way a distance of 150.28 feet to an iron pin; thence run North 83 degrees, 53 minutes, 00 seconds East a distance of 434.79 feet to an iron pin; thence run South 06 degrees, 19 minutes, 45 seconds East a distance of 150.81 feet to an iron pin; thence run South 83 degrees, 57 minutes 12 seconds West a distance of 434.79 feet to an iron pin and point of beginning containing 1.5 acres, more or less, subject to rights of ways of public roads and utilities, zoning and subdivision regulations in effect and easements of record.


