FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00) cash in hand paid, and other good and valuable considerations, the receipt of all of which is hereby acknowledged, Betty Mae Lowrey Veazey and Ann Lowrey Graves, do hereby sell, convey, and warrant unto Christopher Geeslin, the land lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

Beginning at the southwest corner of a 4.05 acre tract, said point being 178.2 feet east of the southwest corner of Section 34, Township 2 South, Range 6 West; thence east 13.0 feet along the south line of said 4.05 acre tract to the point of beginning of the following lot: thence north 25 degrees 06 minutes east 455.96 feet to a point in Byhalia Road; thence south 70 degrees 32 minutes east 141.0 feet to the northeast corner of said 4.05 acre parcel; thence south 2 degrees 03 minutes east 333.65 feet to the southeast corner of said 4.05 acre parcel; thence south 84 degrees 31 minutes west 339.86 feet to the point of beginning and containing 2.025 acres more or less and including the right of way for Byhalia Road. All bearings are magnetic.

And being a portion of the property conveyed to Ruby Collins Lowrey by Warranty Deed of record in Book 98, Page 191, Chancery Clerk's Office of DeSoto County, Mississippi; and a portion of the property conveyed to Leon Lowrey by Warranty Deed of record in Book 88, Page 414, said Clerk's Office. ## ORDER FOR APPOINTMENT OF CONSERVATOR

This matter, having come on to be heard on this the 1st day of April, 1992, upon the petition of C.B. Graves for the appointment of a conservator for his wife, Ann L. Graves, and there being no response made by the Respondent after having been duly served with summons, the Court, having considered the petition, hereby finds, as follows:

(1) Petitioner, C.B. Graves, and the Respondent, Ann L. Graves, are married to each other and are adult residents of Tunica County, Mississippi.

(2) This Court has jurisdiction of the persons and subject matter of this petition pursuant to Mississippi Code Annotated, Section 93-13-251, et seq (1972, as amended). The Respondent, Ann L. Graves, was properly served with process more than five (5) days prior to the date of this hearing, and was served in accordance with Mississippi Rule of Civil Procedure Rule 4(d) (2) (B).

(3) Petitioner and Respondent have been married to each other for a number of years. During these years, Respondent developed a disease known as Alzheimer's disease. Alzheimer's is a progressive disease which has worsened in the Respondent and severely affected her mental capacity. Respondent is now in need of constant care and supervision and is unable to take care of herself or to manage her estate. Her estate consists of some real property and modest personal effects with an estimated total value of approximately \$10,000.00.

(4) Respondent has been examined by two (2) reputable physicians, Dr. Larry Black and Dr. Grady Marlow, both of Senatobia, Mississippi. Both physicians

are duly authorized to practice medicine in this state and have been in actual practice for more than five (5) years each. They have each made a personal physical and mental examination of the Respondent. The results of the examinations have been reported by them in the certificates attached to the petition as Exhibits "A" and "B". Both physicians have concluded that the Respondent is in need a conservator to manage and control her affairs.

(5) Based on Petitioner's personal observation of the Respondent and on the results of the examinations of Drs. Black and Marlow, a conservator should be appointed to have charge and custody of the person and the estate of the Respondent in order to make decisions concerning her best interests. Such decisions should include arrangements for long term hospital or nursing home care, if necessary.

(6) Petitioner is a suitable and proper person to be appointed as the Conservator of the person and estate of the Respondent upon posting a personal bond of \$10,000.00 to cover the value of the Respondent's estate.

It is, therefore, ordered that C.B. Graves shall be, and hereby is, appointed as the Conservator of the person and estate of Ann L. Graves, upon posting a personal bond of \$10,000.00, to have charge and custody of her person and estate with broad authority to make any and all decisions concerning her estate and her personal welfare as deemed by the Petitioner, in his discretion, to be in her best interest, including, but not being limited to, arrangements for long term hospital or nursing home care, if necessary.
