land in DeSoto County, Mississippi, described as follows, to-
wit:

An undivided half interest in and to 46 acres, more
or less, in the Northeast Quarter of Section 11,
Township 2, Range 8 West, described as commencing at
the common corner of Sections 1, 2, 11, and 12
running thence South 0 degrees 04 minutes West along
the Section line 726.0 feet to the Point of
Beginning of the herein described tract; thence
continuing South on the Section line 0 degrees 04
minutes West a distance of 1413.4 feet to a point in
the North line of the Turman land; thence with the
North line of the Turman land West 978.5 feet to a
point in the East right-of-way of U.S. Highway 51;
thence following the East line of said highway North
18 degrees 27 minutes West a distance of 1564.9 feet
to a point; thence East parallel with the Section
line 1443.0 feet, more or less, to the Point of
Beginning.


