DEED OF GIFT

FOR AND IN CONSIDERATION of the love and affection we have for our family, and other good and valuable legal consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantor, CHARLES E. KILLEBREW and wife, RUBY M. KILLEBREW, hereby gives, conveys, and warrants unto the Grantee, THE KILLEBREW FAMILY TRUST, DATED July 26, 1993, CHARLES E. KILLEBREW AND RUBY M. KILLEBREW, TRUSTORS AND/OR TRUSTEES, the land in DeSoto County, Mississippi, being more particularly described as follows:

Lot 38, Section C, Green T Lake Subdivision, in Section 6, Township 3 South, Range 7 West, DeSoto County, Mississippi, as shown by the plat recorded in Plat Book 16, pages 49-52, in the office of the Chancery Clerk of DeSoto County, Mississippi.

This property shall continue to be the homestead of the Grantors and the Trustors/Trustees of this trust and each year Grantees shall sign up for homestead exemption with this property. The Trust provides that the Grantees may do this. By acceptance of this Deed, the parties agree that this conveyance is made subject to subdivision, health department, zoning and other regulations in effect in DeSoto County, Mississippi and rights of way and easements for public roads, flowage, and utilities. Taxes for the year 1993 shall be paid by the Grantee when due. Possession is to be given upon delivery of this deed.


