Respass, as tenants by the entirety with full rights of survivorship and not as tenants in common, the following described land lying and being situated in DeSoto County, Mississippi:

A part of the Northeast Quarter of Section 34, Township 1, Range 8 West, in the unincorporated Village of Horn Lake, more particularly described as commencing at the southeast corner of Lot No. 2, as shown by the plat of S. C. Murphy land recorded in Book 1 at Page 1 in said county, thence north 19 degrees west with the west right-of-way line of the Illinois Central Railroad 234.3 feet to the point of beginning, thence continuing north 19 degrees west with said right-of-way line 112.2 feet to a stake in the north line of the Coggin property, thence west on the north line of the Coggin property 384 feet to a stake, thence south 110 feet to a stake, thence east 418 feet to the point of beginning and being the north 110 feet of the Coggin property.


