FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00), cash in hand paid, and other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged, We, GILLIE POPE WOOD AND HUSBAND, EDGAR WOOD, SR., a/k/a GOODNEY WOOD, do hereby sell, convey, and warrant unto EDGAR WOODS, JR. AND WIFE, DAISY L. WOODS, a/k/a EDGAR WOOD, JR. AND WIFE, DAISY L. WOOD, as tenants by the entirety with full rights of survivorship and not as tenants in common, the land lying and being situated in DeSoto County, Mississippi, more particularly described as follows, to-wit:

BEGINNING at a point 906 feet South of the Northwest Corner of Section 1, Township 2, Range 7 West, DeSoto County, Mississippi. Running thence South along said section line 453 feet to a stake; thence East 541 feet to a stake; thence North 453 feet to a stake; thence West 541 feet to the Point of Beginning, containing 5.63 acres, more or less.


