

ROAD RIGHT OF WAY DEED

In consideration of One Dollar (1.00) and other good and valuable consideration, we, Barbara R. Tillman and Frances D. Robinson, convey and warrant to DeSoto County, Mississippi, the land in DeSoto County, Mississippi described as part of the Northwest Quarter of Section 9, Township 3 South, Range 7 West, and being a strip of land south of the center of Brights Road, more particularly described as follows:

Beginning at the intersection of the west line of the Robinson and Tillman tract and the centerline of proposed Brights Road; thence east along the centerline of proposed Brights Road a distance of 1155 feet to a point in the east line of said Robinson and Tillman tract; thence south along said east line to a point 25 feet south of the centerline of said Brights road; thence west and parallel to the centerline of said Brights road a distance of 1155 feet to a point in the west line of said Robinson and Tillman tract; thence north along said west line of tract to the point of beginning.

This deed conveys 25 feet north of the centerline of Brights Road, whether correctly described or not.

We fully understand that we have the right to receive just compensation for the real property herein described based on an appraisal of said property. We hereby waive our right to just compensation and donate the real property herein described to DeSoto County, Mississippi. We further understand that we have the right to request that a fair market value appraisal of the property be made and we hereby waive that right.

DeSoto County will be required to rebuild any fences.


