

ATTACHMENTLEGAL DESCRIPTION

Lot 5 of the Williams Tract containing 3.0 acres in part of the northeast quarter of Section 30, Township 2 South, Range 7 West, DeSoto County, Mississippi, being further described as follows, to-wit:

Beginning at the intersection of the centerline of Pleasant Hill Road and the east line of Section 30, Township 2 South, Range 7 West, thence north 2633.13 feet along the centerline of Swinnea Road to the intersection of Bankston Road, said point being the northeast corner of Lot 1 of the Williams Tract; thence south 1 degree 04 minutes east 608.0 feet along Swinnea Road to the southeast corner of Lot 2 of the Williams Tract; thence south 2 degrees 06 minutes east 605.0 feet along Swinnea Road to the southeast corner of Lot 4 of the Williams Tract and the beginning point of Lot 5; thence south 89 degrees 07 minutes west 433.39 feet to the southwest corner of said Lot 4 and a point in the west line of the Williams Tract; thence south 4 degrees 53 minutes east 287.27 feet along the west line of said tract to a point; thence south 2 degrees 09 minutes east 20.0 feet to a point in the west line of said Williams Tract; thence north 89 degrees 51 minutes east 419.54 feet to a point in Swinnea Road; thence north 2 degrees 06 minutes west 312.0 feet to the point of beginning and containing 3.0 acres, more or less.
