WILLIAMS JOHNSON, the following described real property located and situated in Desoto County, Mississippi, and more particularly described as follows, to-wit:

A 0.75 acre lot as part of Town Lots 346, 349, 350, 353 and a closed street in Section 13, Township 3 South, Range 8 West; City of Hernando in Desoto County, Mississippi.

Beginning at the Northeast Corner of Town Lot 350; thence North 85°02' East a distance of 43.0 feet to the point of beginning of the following lot; thence South 08°38' East a distance of 317.58 feet to a point in the North right of way Hill Street (20 feet from centerline); thence South 79°50' West along said right of way a distance of 80.0 feet to a point; thence North 08°38' West a distance of 180.0 feet to a point; thence North 43°15' West a distance of 184.17 feet to a point; thence North 85°02' East a distance of 185.0 feet to the point of beginning containing 0.75 acres more or less. All bearings are magnetic.






