1. Affiant is familiar with the family history of Frank Guy, Sr., the deceased, who was the owner of the following property at the time of death:

Situated in City of Southaven, County of Desoto, State of Mississippi, described as follows, to-wit:

Located in Section 20, Township 1 South, Range 7 West.
