Jones and wife, Sharon Jones, do hereby sell, convey and quitclaim unto William E. Bailey and wife, Sheri D. Bailey, as tenants by the entireties with full rights of survivorship and not as tenants in common all their right, title and interest in and to the land lying and being situated in DeSoto County, Mississippi, to-wit:


