FOR AND IN CONSIDERATION OF the sum of Ten and No/100 Dollars (\$10.00) cash in hand paid, and other good and valuable consideration, the receipt and sufficiency of all of which are hereby acknowledged the Trustees of THE MARY OLIVER VEAZEY TRUST each hereby sell, convey and quitclaim unto THE F.F. VEAZEY LIMITED PARTNERSHIP, any and all interest said trust may have in the following described property situated in Counties of Tate and DeSoto, Mississippi, being more particularly described as follows:

PARCEL 1: The North Half of the South Half of Section 18, Township 4 South, Range 6 West, Tate County, Mississippi, and containing 160 acres, more or less.

PARCEL 2: The South Half of the South Half of Section 18, Township 4 South, Range 6 West, Tate County, Mississippi, and containing 160 acres, more or less.

PARCEL 3: Beginning at the Northwest Corner of Section 19, Township 4 South, Range 6 West, Tate County, Mississippi, and running thence N 89 degrees 28' 50" E along Beartrail Creek a distance of 3492.42 feet; thence S 10 degrees, 46' 12" W a distance of 5384.80 feet to a point on the South line of said Section 19, thence S 89 degrees 28' 50" W a distance of 1212.41 feet to a point; thence N 01 degrees 07' 38" W along a fence line a distance of 1326.61 feet to an iron pin; thence N 47 degrees 25' 00 degrees E a distance of 90.05 feet; thence N 02 degrees 22' 57" W along a fence line a distance of 2726.76 feet; thence N 89 degrees 43' 55" W a distance of 369.3 feet; thence N 01 degrees 13' 05" W a distance of 512.7 feet; thence N 87 degrees 18' 48" W a distance of 809.03 feet to an iron pin on the west side of a country road; thence N 01 degrees 13' 03" W a distance of 604.88 feet to the point of beginning and containing 233.1 acres, more or less. Meaning to describe the same property conveyed from J. Gary Veazey to F.F. Veazey, Jr., on June 4, 1991 recorded in Deed Book A68, pages 325-327.

PARCEL 4: The Northeast Quarter of Section Six (6), Township Four (4), Range Nine (9) West, and all of Section Five (5), Township Four (4), Range Nine (9) West, that is located in DeSoto County, Mississippi, being all of said Section, Township, and Range that is North of the old channel of Coldwater River, except a small parcel of land acquired by the United States of America for channel improvement purposes, as shown by Judgement of Declaration of Taking of perpetual easement of record in Book 31, Page 477, of the Deed of Records of said County, to which reference is made, BUT LESS AND EXCEPT THEREFROM, and undivided one/half right, title and interest in and to all oil, gas and other minerals lying in, under or beneath the above-described lands which was reserved by Bessie McLean Crump in her deed to W. Bruce Bowdon of date January 26, 1956, and of record in Book 42, Page 579 of the Deed Records of said County. Meaning to described that same property conveyed to F.F. Veazey and C.W. Veazey in Deed Book 44, Page 112 in the DeSoto County Chancery Clerk's Office, July 7, 1957.

PARCEL 5: Approximately 10 acres located in Section 8, Township 4, Range 9, Tate County, Mississippi, south of the old channel of the Coldwater River from the described land above (Parcel 5) in DeSoto County, Mississippi, as per deed recorded in Book NN, Page 485 in the office of the Chancery Clerk of Tate County, Mississippi on January 8, 1958. By way of explanation, the Cub Lake Place located in DeSoto County, Mississippi, is owned by the heirs and/or beneficiaries of C.W. Veazey (undivided 1/2 interest) and the beneficiaries of F.F. Veazey, Jr. (undivided 1/2 interest).






