Whitten Jenkins, fka, Bettye Bridgforth Whitten, do hereby give, convey and warrant unto Kristopher Andrew Whitten, as custodian for Kara Rebekah Whitten, under the Mississippi Uniform Transfers To Minors Act, an undivided one-eighteenth interest in and to the land lying and being situated in DeSoto County, Mississippi, more particularly described as follows, to-wit:

52 acres, more or less, being the south half of the 104 acre tract/described as follows: situated in NW 1/4 & SW 1/4
