FOR AND IN CONSIDERATION of the love and affection that I have for the Grantee herein, We, STUART LEE WILLIAMS and wife, RUTH KUNTZ WILLIAMS, do hereby give, convey and warrant unto BETH ELLEN PERCIFULL, an undivided one-half interest in and to the property lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

A parcel of land being part of the Stuart Lee Williams Tract located in the Southwest Quarter of Section 17, Township 2 South, Range 6 West, DeSoto County, Mississippi and being more particularly described as follows, to-wit:

Commencing at a point 660.00 feet North of the Southeast corner of the Southwest Quarter of said Section 17, Township 2 South, Range 6 West; thence South 88°-28'-00" West a distance of 380.00 feet to a point; thence South 89°-49'-00" West a distance of 440.00 feet to a point; thence South 89°-17'-33" West a distance of 465.77 feet to a 3/8" rebar found at the Southeast corner of the Stuart Lee Williams tract; said point being the point of beginning for the following tract; thence South 88°-54'-38" West a distance of 325.22 feet to a 3/8" rebar set; thence North 00°-44'-05" West a distance of 951.54 feet to a 3/8" rebar set on the South line of Dunn Lane (40.00 feet from Centerline); thence North 89°-51'-49" East along the South line of Dunn Lane a distance of 341.77 feet to a 3/8" rebar set; thence South 00°-16'-00" West a distance of 946.10 feet to the point of beginning and containing 7.26 acres, subject to existing easements, right-of-ways, subdivision and zoning regulations in effect in DeSoto County, Mississippi.


