FOR AND IN CONSIDERATION of the love and affection we have for each other,
We, CHARLES E. GILLESPIE and Wife, CORENNA GILLESPIE give, convey, and
quitclaim unto CHARLES E. GILLESPIE and Wife, CORENNA GILLESPIE, as tenants by
the entirety with full rights of survivorship and not as tenants in common the land in
DeSoto County, Mississippi, described as follows, to-wit:

Northeast corner of said Section 5; thence South 86 degrees West 2,438.33
feet to a point; thence South 4 degrees East 495 feet to the point of beginning;
thence North 86 degrees East 60 feet to a point thence South 4 degrees East
420 feet to a point; thence South 86 degrees West 100 feet to a point; thence
North 4 degrees West 420 feet to a point; thence North 86 degrees East 40
feet to the point of beginning, and being the same property conveyed to
Charles E. Gillespie and Wife, Corenna Gillespie by deeds recorded in Deed
Book 113, page 287 and Deed Book 113, page 288.

By way of explanation, the purpose of this deed is to create a tenancy by the entirety
with full rights of survivorship.


