SUBSTITUTED TRUSTEES DEED

WHEREAS, on April 30, 1999, Harry L. Coleman, Jr. and Natallia L. Colemand, husband and wife, executed a Deed of Trust to Arnold Weiss, Trustee for the benefit of Pulaski Mortgage Company, which Deed of Trust is filed for record in Book 1108, Page 147 in the office of the Chancery Clerk of Desoto County at Hernando, Mississippi; and

WHEREAS, said Deed of Trust was subsequently assigned to Union Planters Bank, National Association by instrument dated May 17, 1999 and recorded in Book 1131, Page 235 of the aforesaid records; and

WHEREAS, as authorized by the aforesaid Deed of Trust and in strict accordance therewith, Union Planters Bank, N.A., being one and the same as Union Planters Bank, National Association, appointed and substituted J. 




