

TRUSTEE'S DEED

WHEREAS, on January 7, 2000, GREGORY T. MEEKS and wife, JENNY R. MEEKS executed a Land Deed of Trust to Kenneth E. Stockton, Trustee for the benefit of ROBERT L. WOODS and H.H. 
