CARLOCK do hereby convey and warrant unto the CITY OF OLIVE BRANCH, A MUNICIPAL CORPORATION, for road right-of-way the land lying and being situated in the City of Olive Branch, DeSoto County, Mississippi, more particularly described as follows, to wit:

DESCRIPTION OF A 9555 SQUARE FOOT RIGHT OF WAY PARCEL OF THE CARLOCK LOT 14 LOCATED IN PART OF THE NORTHEAST QUARTER OF SECTION 21; TOWNSHIP 1 SOUTH; RANGE 6 WEST; CITY OF OLIVE BRANCH IN DESOTO COUNTY, MISSISSIPPI.

Beginning at the northeast corner of Section 21; Township 1 South; Range 6 West; thence south 1545.72 feet along Germantown Road to a point; thence west 40 feet to a point on the north line of the Carlock Lot 14 tract, and being the point of beginning of the following parcel; thence west 34.05 feet along the north line of the Carlock Lot 14 tract to a point; thence south 296.0 feet to a point on the south line of the Carlock Lot 14 tract; thence east 30.51 feet along the south line of the Carlock Lot 14 tract to a point on the proposed 40 foot right of way line; thence north 296.0 feet along said proposed 40 foot right of way line to the point of beginning and containing 9555 square feet more or less.




