

TRUSTEE'S QUIT CLAIM DEED OF DISTRIBUTION

THIS INDENTURE made and entered into this 10TH day of February, 2003, by and among THEODORE J. JOHNSON, JR., TRUSTEE OF THE RESIDUARY TRUST UNDER THE LAST WILL AND TESTAMENT OF JOHN CASH KING, DECEASED (the "Residuary Trust"), Party of the First Part, and JOHN CASH KING, JR. and ROBERT NANCE KING, Parties of the Second Part:

W I T N E S S E T H, That:

WHEREAS, the hereinafter described real estate was conveyed to Party of the First Part by Executor's Quit Claim Deed of Allocation dated July 19, 1990, of record in the office of the DeSoto County, Mississippi Chancery Clerk in Deed Book 256, Page 451;

WHEREAS, Mary Nance King, wife of said decedent died on June 24, 2002, and under the terms of the Residuary Trust, upon the death of Mary Nance King, the Residuary Trust terminates and is to be distributed in equal shares to such of said decedent's children, Richard Jackson King, John Cash King, Jr. and Robert Nance King, as shall be living at the death of Mary Nance King, or all to the survivor if only one of them shall then be living; provided, however, if any of said decedent's children is not then living but has left issue then living said issue shall take in equal parts per stirpes the share which such child would have taken if then living;

WHEREAS, John Cash King, Jr. and Robert Nance King survived Mary Nance King, but Richard Jackson King predeceased Mary Nance King leaving no issue surviving her, so that the property of the Residuary Trust is to be distributed in equal shares to John Cash King, Jr. and Robert Nance King, Parties of the Second Part herein.

NOW, THEREFORE, for and in consideration of the premises, Party of the First Part does hereby bargain, sell, convey and quitclaim in equal shares unto Parties of the Second Part




EXHIBIT "A"

Situated and being in the County of DeSoto, State of Mississippi, to-wit:

All that same property conveyed to Dr. John Cash King (being one and the same person as John Cash King) by deed from Richard W. Hussey dated June 16, 1982, of record in the office of the Chancery Clerk of DeSoto County, Mississippi, in Book 159, Page 545, records of Warranty Deeds of said county and being described in said deed as follows:

All that certain land situated south and east of the centerline of the Coldwater River Diversion Canal constructed by the U.S. Corps of Engineers in Sections Seventeen (17) and Eighteen (18), Township Four (4) South, Range Nine (9) West and all of that part of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section Nineteen (19), Township Four (4) South, Range Nine (9) West, in DeSoto County, situated south and east of the centerline of said Diversion Canal.

Please index in all quarter sections of Section 18. As Section 17 is not located in Desoto County there is no need to index that section.

Less and except an undivided three-fourths (3/4) interest in and to all oil, gas or other minerals in, on or under said land (but not including coal and lignite), it being the intention of Part of the First Part to convey to Party of the Second Part only the undivided one-fourth interest in and to such mineral estate as conveyed to John Cash King by Richard Hussey by the aforesaid deed.
