EXHIBIT A
LEGAL DESCRIPTION

Beginning at a point in the east right of way of Malone Road, said point being 296.5 feet south of the north line of the southwest quarter of Section 2, Township 3, Range 7 West; thence north 85 degrees 37 minutes east and parallel to the north line of said quarter section 722.0 feet to a point; thence south 4 degrees 15 minutes east and parallel to said road right of way 271.5 feet to a point; thence south 85 degrees 37 minutes west 722.0 feet to a point in said road right of way; thence north 4 degrees 15 minutes west along said right of way 271.5 feet to the point of beginning and containing 4.5 acres, more or less. All bearings are magnetic.
