for and in consideration of the sum of One dollar(s) (\$1.00) to me cash in hand paid by Entergy Mississippi, Inc., a corporation, the receipt of which is hereby acknowledged, do hereby grant and convey to Entergy Mississippi, Inc., its successors and assigns, collectively "GRANTEE", the right to access, clear, and keep clear, a strip of land 11 feet wide adjacent and parallel to the Swinnea Road right of way line of Desoto County, Mississippi, described as follows to-wit:

A certain parcel of land lying and being situated in the NE/4 SE/4 of Section 30, Township 1 South, Range 7 West, Desoto County, Mississippi, as shown on the sketch designated as EXHIBIT "A", attached hereto and made a part hereof.

Grantee shall have the full and continuing right to clear and keep clear vegetation within or growing into said strip of land and the further right to remove or modify from time to time trees, limbs, and/or vegetation outside the said right of way which Grantee considers a hazard to any of its electric power or communications facilities or a hazard to the rendering of adequate and dependable service to Grantor or any of Grantee's customers, by use of a variety of methods used in the vegetation management industry.


