For and in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid and other good, valuable and legal considerations, the receipt and sufficiency of which are hereby acknowledged, we, the Grantors hereinabove mentioned, **LAURA DELL RICKS EASLEY and R. THOMAS EASLEY**, do hereby bargain, sell, convey and quit claim unto the Grantees hereinabove mentioned, **R. THOMAS EASLEY, and wife LAURA RICKS EASLEY**, as tenants by the entirety with full rights of survivorship and not as tenants in common, all of our right, title and interest in and to the property located and situated in DeSoto County, Mississippi, and more particularly described as follows:

10.12 acres in the northeast quarter of Section 33, Township 3, Range 8, described as: Beginning at a point 1265 feet south of the northeast corner of said section 33, which point is in the center of Tulane Road; thence west 795 feet to a point; thence south 555 feet to a point; thence east 795 feet to a point in the center of Tulane Road in the east line of said section; thence north on the section line 555 feet to the point of beginning, containing 10.12 acres, more or less.

INDEXING INSTRUCTION: property located in the northeast quarter of Section 33, Township 3, Range 8, DeSoto County, Mississippi.

By way of explanation, this is the same property conveyed to the Grantors by Deed of Gift recorded in Deed Book 129 at page 69 of the land deed records. The purpose of this deed is to create a tenancy by the entirety with right of survivorship between the grantees.

This conveyance is made subject to all road rights of way, public utility easements, restrictive covenants, zoning and subdivision regulations and health department regulations in effect in DeSoto County, Mississippi.


