

TRACT I

Part of the Southwest Quarter of Section 16, Township 2 South, Range 6 West, DeSoto County, Mississippi and being more particularly described as follows, to-wit:

Beginning at a point commonly accepted as the Southeast corner of the Southwest Quarter of said Section 16; thence run North 89 degrees 52 minutes 59 seconds West a distance of 732.59 feet along the south line of said quarter section to a point; thence run North 00 degrees 05 minutes 41 seconds East a distance of 593.16 feet to a point; thence run North 88 degrees 21 minutes 21 seconds East a distance of 367.48 feet to a point; thence run North 01 degrees 38 minutes 39 seconds West a distance of 406.49 feet to the southwest corner of the Alice Gertrude Tomlin property; thence run North 88 degrees 21 minutes 21 seconds East a distance of 224.04 feet along the south line of said Tomlin property to the southeast corner of said Tomlin property; thence run North 01 degrees 38 minutes 39 seconds West a distance of 214.04 feet along the east line of said Tomlin property to a point on the centerline of Dunn Lane; thence run North 81 degrees 05 minutes 16 seconds East a distance of 125.92 feet along said centerline to a point on the east line of said quarter section; thence run South 01 degrees 38 minutes 06 seconds East a distance of 1251.77 feet along the east line of said quarter section to the Point of Beginning and containing 13.93 acres.
