FOR AND IN CONSIDERATION of the sum of One Dollars (\$10.00), cash in hand paid and other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, EDWARD T. AUTRY, Administrator of the Estate of Catherine B. Joyner, Deceased, pursuant to Letters of Administration granted in Cause No. 05-11-1794 of the Chancery Court of DeSoto County, Mississippi, Grantor, does convey title unto JOHN H. NABORS and KATHERINE J. NABORS, as tenants by the entirety with full rights of survivorship, in fee simple in as full and ample a manner as the same was held, possessed, and enjoyed, or might have been held, possessed, and enjoyed, by said decedent, that certain 5.92 acres, more or less, lying and being situated in the Southwest Quarter of the Section 18, Township 1 South, Range 6 West, DeSoto County, Mississippi, described as follows, to-wit:

Part of the Southwest Quarter of Section 18, Township 1, Range 6 West, DeSoto County, Mississippi, and being more particularly described as following, to-wit: Commencing at a point commonly accepted as the Southwest corner of said quarter section, said point being the intersection of the centerlines of Stateline Road and Davidson Road; thence run North 00°-12'-01" West a distance of 877.50 feet along said centerline of Davidson Road to a point; thence run North 89°-47'-59" East a distance of 40.00 feet to a point on the east right-of-way line of said road, said point being the Point of Beginning; thence run North 00°-12'-01" West a distance of 276.81 feet along said east right-of-way line to a point on the Mississippi-Tennessee State Line; thence run North 89°-12'-39" East a distance of 960.14 feet along said Mississippi-Tennessee State Line to a point; thence run south 00°-12'-01" East a distance of 260.23 feet to a point; thence run South 89°-47'-59" West a distance of 960.00 feet to the Point of Beginning and containing 5.92 acres, more or less. Bearings are based on true North as determined by solar observation.

By way of information, Edward T. Autry is the Administrator of the Estate of the Catherine B. Joyner administered in Cause No. 05-11-1794 of the Chancery Court of DeSoto County, Mississippi. This conveyance is made pursuant to Court Order. 


