QUIT CLAIM DEED



1. The name of the trust is:


JOHN L. CRIDDLE REVOCABLE LIVING TRUST, dated February 2, 2006, JOHN L. CRIDDLE, Trustee.

10. This Proof of Trust is dated February 2, 2006.






