FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00), cash in hand paid by the Grantees to the Grantors, and other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged, **BRENTWAY INVESTMENTS, a Mississippi general partnership,** does hereby grant, bargain, sell, convey and warrant unto **CANDACE M. MEDLIN and MARK WAYNE LOTT as joint tenants with full right of survivorship and not as tenants in common,** the land lying and being situated in DeSoto County, Mississippi, more particularly described as follows, to-wit:

Lot 1, Dixiecreek Estates Subdivision, in Section 35, Township 3 South, Range 6 West, DeSoto County, Mississippi, as per plat thereof record in Plat Book 98, Pages 28-30, in the Office of the Chancery Clerk of DeSoto County, Mississippi, together with the improvements, hereditaments and appurtenances thereunto belonging.

TO HAVE AND TO HOLD unto the Grantees, their heirs and assigns, in fee simple forever, and free from all liens and encumbrances except for the following: subdivision and zoning regulations in effect in DeSoto County, Mississippi, to rights of way and easements for public roads and public utilities, and to the restrictive covenants of record for said subdivision. This property is also subject to Restrictive Covenants recorded at Plat Book 98, Page 28-30; Easements of record at Plat Book 98, Page 28-30; Deed Book 33, Page 169; Book 41, Page 107; and Book 41, Page 548, all in the Chancery Clerk's Office of DeSoto County, Mississippi. Possession is to be given upon delivery of the deed.


