FOR AND IN CONSIDERATION of the sum of Ten Dollars (\$10.00), cash in hand paid, and other good and valuable considerations, the receipt of all of which is hereby acknowledged, We, ALICE GLOVER, CORNELL WILSON, DARLENE MASTERS, DELOIS ROY and SHERRIE MARIE GLOVER, do hereby sell, convey and warrant unto WILLIE HUE WILSON, all our right, title and interest in and to the land lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

5.0 acres located in the Northeast Quarter of Section 28, Township 1 South, Range 5 West, DeSoto County, Mississippi and being more particularly described as follows, to-wit:

Beginning at a found 5/8 inch rebar marking the Northwest corner of Willie Hue Wilson's 5.0 acre tract recorded in Book 257, Page 101 and being a record distance of South 89°-39'-34" East 2673.46 feet and South 00°-58'-10" West 1223.36 feet from a P.K. nail marking the Northwest corner of said Section 28 per a previous survey by Tom King, Jr. dated April 27, 1989. From said beginning point run thence South 89°-37'-23" East 466.70 feet to a found 5/8 inch rebar. Run thence South 00°-58'-10" West 466.70 feet to a found 5/8 inch rebar; run thence South 89°-37'-23" East 193.30 feet to set 1/2 inch rebar; thence run North 00°-58'-10" East 660.00 feet to a set 1/2 inch rebar; run thence North 89°-37'-23" West 660.0 feet to a set 1/2 inch rebar; run thence South 00°-58'-10" West 193.30 feet to the point of beginning and containing 5.0 acres more or less.






