Lot 565, Section B, South half of DeSoto Village Subdivision, situated in Section 33, Township 1 South, Range 8 West, DeSoto County, Mississippi, as per plat of record in Plat Book 8, Pages 16-19, in the Chancery Clerk's Office of DeSoto County, Mississippi.

Being the same property acquired by the party of the first part pursuant to the provision of the National Housing Act, as amended (12 USA 1701 et seq.) and the Department of Housing and Urban Development Act (42 U.S.C. 3531), by deed dated **October 25, 2005** and recorded in **Book 513 Page 231** in the Chancery Clerk's Office of DeSoto County, Mississippi.


