


CLERK'S CERTIFICATE

ORDINANCE: #92-01-21

ORDINANCE CLOSING PUBLIC STREET KNOWN AS INTERSTATE BOULEVARD

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF HORN LAKE, MISSISSIPPI:

SECTION 1. PURSUANT TO MISSISSIPPI CODE ANNOTATED 1972 AS AMENDED SECTION 21-37-7, THE CITY OF HORN LAKE, MISSISSIPPI, DOES HEREBY PURSUANT TO SUCH POWER AUTHORIZED CLOSING AND VACATE THE CITY STREET HERETOFORE PREVIOUSLY KNOWN AS "OLD INTERSTATE BOULEVARD." SAID PUBLIC STREET BEING LOCATED IN SECTION 36, TOWNSHIP 1 SOUTH, RANGE 8 WEST, IN THE MUNICIPAL CORPORATE LIMITS OF THE CITY OF HORN LAKE, DESOTO COUNTY, MISSISSIPPI, WHICH IS MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

SECTION 36, TOWNSHIP 1 SOUTH, RANGE 8 WEST, HORN LAKE, DESOTO COUNTY, MISSISSIPPI

30 FEET EITHER SIDE OF THE CENTERLINE OF OLD INTERSTATE BOULEVARD FURTHER DESCRIBED AS STARTING AT THE INTERSECTION OF THE SAID CENTERLINE WITH THE WESTWARD EXTENSION OF THE NORTH LINE OF LOT 3, SOUTHAVEN VILLAGE INDUSTRIAL PARK SUBDIVISION AS RECORDED IN PLAT BOOK 17, PAGE 18 OF THE DESOTO COUNTY CHANCERY CLERK'S OFFICE, THENCE GO ALONG SAID CENTERLINE IN A NORTHEASTWARDLY DIRECTION TO THE INTERSECTION OF THE SOUTH LINE OF THE SOUTHWEST ACCESS ROAD BUILT AS PART OF THE MISSISSIPPI HIGHWAY DEPARTMENT PROJECT NO. IR-55-4(53).

SECTION 2. THE ABUTTING LAND OWNER, MARK LOYD, HAS HERETOFORE BEEN OFFERED DUE COMPENSATION BY THE CITY OF HORN LAKE AND SAME HAVING BEEN REJECTED PER WRITTEN LETTER ADDRESSED TO THE CITY OF HORN LAKE.

SECTION 3. THAT THE HERETOFORE MENTIONED LAND OWNER HAS SUSTAINED NO DAMAGE BUT WILL BE FINANCIALLY BENEFITED FROM THE CLOSING OF SAID STREET AND THAT THERE ARE NO OTHER ADJACENT OR ABUTTING LAND OWNERS TO WHICH COMPENSATION WOULD BE REQUIRED.

SECTION 4. THAT THIS ORDINANCE SHALL BECOME EFFECTIVE THIRTY (30) DAYS AFTER THE FIRST DATE OF PUBLICATION IN A COUNTYWIDE NEWSPAPER.

THE FOREGOING ORDINANCE, HAVING BEEN REDUCED TO WRITING, READ AND CONSIDERED, SECTION BY SECTION AND AS A WHOLE, AND SAME HAVING BEEN INTRODUCED BY PROPER MOTION BY ALDERMAN WALTHALL AND DULY SECONDED BY ALDERMAN SHANNON BY THE ADOPTION THEREOF AND A VOTE TAKEN THEREON HAVING THE FOLLOWING RESULTS: THOSE PRESENT AND VOTING IN FAVOR OF THE ADOPTION OF EACH AND ALL OF THE SECTIONS AND PROVISIONS OF THE FOREGOING ORDINANCE AND FOR THE ORDINANCE AS A WHOLE:
