1. In this case, the claim of DeSoto County, Mississippi to have condemned certain lands named in the Petition, as described in Exhibit "A" attached hereto, and incorporated herein was presented to the Court for a trial.

2. The Defendants did not appear on said trial date, being December 17, 2004. It was further shown to the Court that the Defendants waived service of process, and additional process has been appropriately published, the Defendants have not answered the Petition, nor have they filed a Statement of Values. Several of the Defendants have contacted counsel for the Petitioner to indicate their desire to receive the Court approval of compensation for the property in question.

- j. Sharon Jefferson



8. All costs are assessed to the Petitioner.




